PRE-EMPLOYMENT INFORMATION AND APPLICATION

Thank you for your interest in joining the Kimball Township Fire Department. Your decision to join the Fire and Emergency Medical Services field is the first step in what we hope will be an enjoyable and challenging career. The Kimball Township Fire Department hires paid on-call firefighters who may also staff shifts once you have graduated from a state-approved fire academy and have earned a medical license. Now that you have made the decision to join a brotherhood/sisterhood of men and women who serve their communities, friends, and neighbors as a firefighter please complete the attached job application in full and drop it off at our Station One/Administrative Office.

Once we receive your completed application we will review and if you meet the minimum qualifications, we will contact you for an interview. After the job interview, we will review the results and schedule you for a physical agility test and obtain approval to hire from the Kimball Township Board of Trustees. Once approval from the Township Board has been obtained you will undergo a physical and your background check will be completed.

As a firefighter, or emergency medical services provider at the Kimball Township Fire Department you will respond to a wide variety of emergency and non-emergency incidents. If you are seeking employment as a communications officer, you will be tasked with managing the communications with our incident commanders, central dispatch authority, utility companies, and mutual-aid departments.

We look forward you meeting you, learning about you and your goals, and seeing you learn the skills needed to make you an excellent member of the Kimball Township Fire Department.

Requirements for Employment as a Paid On-Call Firefighter/EMS provider/Communications personnel

To apply you must:

- 1. Be at least 18 years of age.
- 2. Have a high school diploma or GED
- 3. Have a valid Michigan driver's license.
- 4. No felony convictions

The following must be completed in order before employment begins:

- 1. Complete the attached job application.
- 2. Meet with the Interview Board.
- 3. Pass a Criminal and Driving Background Check.
- 4. Pass a physical ability test.
- 5. Be approved by the Fire Administration Board/Kimball Township Board of Trustees
- 6. Complete and pass a physical.

The following must be completed after employment begins.

- 1. Work with the various Field Training Officers to learn basic fireground skills as outlined in the department's Blue Book orientation manual.
- 2. Maintain required attendance at incidents, training, work details, and meetings.
- 3. Complete a department-paid and state-approved Fire Academy (firefighter only)
- 4. Complete a department-paid Medical First Responder licensing program. (EMS and firefighter)
